OFFICIAL RULES FOR MICHIGAN UNITED CONSERVATION CLUBS GUN-A-MONTH GREAT OUTDOORS SWEEPSTAKES

1. NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.
2. Sweepstakes open to legal residents of the United States age 18 or older and otherwise eligible to purchase a firearm.

The Michigan United Conservation Clubs ("MUCC") Gun-A-Month Sweepstakes ("Sweepstakes No. 1") begins at 12:01 a.m. Eastern Time (ET) on February 1, 2018 and ends 11:59 p.m. (ET) on January 31, 2019 ("Entry Period").

The Michigan United Conservation Clubs Great Outdoors ("Sweepstakes No. 2") begins at 12:01 a.m. (ET) on February 1, 2018 and ends 11:59 p.m. (ET) on January 26, 2019 ("Entry Period").

All federal, state and local laws and regulations apply. Void where prohibited by law. Sweepstakes is governed by US Law.
3. HOW TO ENTER: In order to enter the sweepstakes, you must fill out and return the bottom portion of the enclosed ticket.

Entries must be received by MUCC no later than 11:59 p.m. (ET) on January 31, 2019.

All entries become the property of MUCC and will not be returned or acknowledged. Limit: One entry per person. Mass entries or entries generated via a facsimile or copy machine or other automated devices will be disqualified. No mechanical reproductions are permitted. Photocopy or incomplete entries are void.
4. CONSUMER DISCLOSURES: You have not yet won. No purchase necessary. For each of the Sweepstakes, two prizes will be awarded each month during the Entry Period. Individual prizes for Sweepstakes Approximate Retail Value (ARV): \$506.41. Maximum ARV of all prizes of Sweepstakes guaranteed to be awarded: \$12,154.53. Odds of winning depend on the number of eligible entries received per monthly drawing, estimated at 1: 20,000.

WINNER SELECTION: Monthly winners for Sweepstakes will be selected per month from the eligible entries received during the months of February, 2018 through and including 11:59 p.m. on January 31, 2019. All eligible entries will be combined as received during the entry period. Two eligible entries for Sweepstakes will be selected monthly at random from all eligible entries for those sweepstakes received up to the date of that month's drawing. Each monthly random drawing will be held at MUCC's offices in Lansing, Michigan on the last Friday of every month between the hours of 12:00pm and 11:59pm. To be eligible for a given monthly drawing of Sweepstakes, your eligible entry must be received no later than 11:59 p.m. (ET) on the Tuesday before the drawing.
6. NOTIFICATION OF WINNERS: All random drawings will be conducted under supervision of MUCC whose decision is final and binding. Each winner will be notified by mail, phone or email within 14 days after the drawing. To be declared a winner, all potential winners must satisfy all applicable state and federal laws concerning firearm ownership and possession prior to receiving the firearm prize. If the potential winner is ineligible to receive the prize, an alternate winner will be selected. Prizes will be awarded within 30 days after prize notification. If a prize notification is returned as undeliverable, it will result in disqualification, and the corresponding prize will be awarded to an alternate winner in a separate random drawing from all non-winning eligible entries.
