The meeting was called to order by MUCC Vice President Greg Peter at 12:32PM.

Dawn Levey, Executive Board Region 5 Director led the Pledge of Allegiance and the Conservation Pledge.

George Lindquist, President of MUCC, and Greg Peter, Vice President of MUCC, gave a brief introduction of the meeting and introduced the MUCC board members and staff. Everyone in the room introduced themselves as well.

Gary Summers (Ted Schulz) moved to approve the agenda. MOTION CARRIES

Jim Jett (Bruce Levey) moved to approve the minutes from Dec 7, 2019 Conservation Policy Board. MOTION CARRIES.

Doug Craven, the Natural Resources director from Little Traverse Bay Bands of Odawa Indians discussed treaty rights and natural resources management. Total licenses issued were discussed. 17% of LTBB citizens are license holders. Youth education is a big push to teach tribal treaty rights for hunting and fishing. Majority of funding comes from Bureau of Indian Affairs.

Chad Fedewa of DNR Wildlife Division covered the vacancy of Wildlife Chief, budget outlook which is not great due to low PR dollars and license sales. He also covered deer regulations, which will likely occur in two phases. CWD was also covered, and additional funding requests for research. Research goals are management tools, transmission methods and environmental contamination.

Chad and Amy Trotter, MUCC Executive Director, shared a bit about the MUCC On the Ground program as a "moment for the mission."

### **Operating Policies and Practices**

Greg Peter discussed a policy board description document that was developed by an adhoc committee.
