Official Rules for Michigan United Conservation Clubs Gun-a-Month and Great Outdoors Sweepstakes

- 1. NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.**
- 2. Sweepstakes open to legal residents of the United States age 18 or older and otherwise eligible to purchase a firearm. The Michigan United Conservation Clubs ("MUCC") Gun-A-Month ("Sweepstakes No. 1") begins at 12:01 a.m. Eastern Time (ET) on February 1, 2023 and ends 11:59 p.m. (ET) on January 23, 2024 ("Entry Period"). The Michigan United Conservation Clubs Great Outdoors ("Sweepstakes No. 2") begins at 12:01 a.m. (ET) on February 1, 2023 and ends 11:59 p.m. (ET) on January 23, 2024 ("Entry Period"). All federal, state and local laws and regulations apply. Void where prohibited by law. Sweepstakes is governed by US Law.**
- 3. HOW TO ENTER:** There are two ways to enter each of the sweepstakes. (I) Ticket Method: In order to enter the sweepstakes, you must fill out and return the bottom portion of the enclosed ticket. Entries must be received by MUCC no later than 11:59 p.m. (ET) on January 18, 2024. All entries become the property of MUCC and will not be returned or acknowledged. Limit: One entry per person. Mass entries or entries generated via a facsimile or copy machine or other automated devices will be disqualified. No mechanical reproductions are permitted. Photocopy or incomplete entries are void. (II) Alternate Method: During the entry period mail complete a 3" x 5" postcard with your name, address, age, email address and daytime phone number legibly hand-printed in ink in capital letters, then sign your name in ink at the bottom of the card. Mail the card with sufficient pre-paid postage to MUCC, 2101 Wood Street, Lansing, Michigan 48912. Entries must be mailed separately (up to one entry for each sweepstakes per mailing/return address). Entries must be postmarked by January 11, 2024 and must be received at MUCC's headquarters 2101 Wood Street, Lansing MI 48912 no later than 11:59 p.m. (ET) on January 18, 2024. All entries become the property of MUCC and will not be returned or acknowledged. Limit 1 entry per sweepstakes per person.
- 4. CONSUMER DISCLOSURES:** You have not yet won. No purchase necessary. For each of the Sweepstakes, two prizes will be awarded each month during the Entry Period. Individual prizes for Sweepstakes No. 1 Approximate Retail Value (ARV): \$506.41. Maximum ARV of all prizes of Sweepstakes No. 1 guaranteed to be awarded: \$12,154.53. Individual monthly prizes for Sweepstakes No. 2 Approximate Retail Value (ARV): \$250 and \$150. Maximum ARV of all prizes of Sweepstakes No. 2 guaranteed to be awarded: \$4,800.00. Odds of winning depend on the number of eligible entries received per monthly drawing, estimated at 1: 20,000. - 5. WINNER SELECTION:** Monthly winners for Sweepstakes will be selected per month from the eligible entries received during the months of February, 2023 through and including 11:59 p.m. on January 23, 2024. All eligible entries will be combined as received during the entry period. Two eligible entries for Sweepstakes will be selected monthly at random from all eligible entries for those sweepstakes received up to the date of that month's drawing. Each monthly random drawing will be held at MUCC's offices in Lansing, Michigan on the last Thursday of every month between the hours of 8:30a.m. and 12:00p.m. To be eligible for a given monthly drawing of Sweepstakes, your eligible entry must be received no later than 11:59 p.m. (ET) on the Tuesday before the drawing. Last drawing for both sweepstakes will take place January 23, 2024.
- 6. NOTIFICATION OF WINNERS:** All random drawings will be conducted under supervision of MUCC whose decision is final and binding. Each winner will be notified by mail, phone or email within 14 days after the drawing. To be declared a winner, all potential winners must satisfy all applicable state and federal laws concerning firearm ownership and possession prior to receiving the firearm prize. If the potential winner is ineligible to receive the prize, an alternate winner will be selected. Prizes will be awarded within 30 days after prize notification. If a prize notification is returned as undeliverable or the winner fails to respond to prize notification after 30 days, it will result in disqualification, and the corresponding prize will be awarded to an alternate winner in a separate random drawing from all non-winning eligible entries. Entry & acceptance of prize constitute permission to use a winner's name, prize won, hometown & likeness for promotional purposes including online posting without further compensation, except where prohibited by law. Winners shall be provided the option to receive their prize in person at a location determined by MUCC. Alternatively, winners may request that their prize is shipped to an eligible receiving location of their choosing (location must provide documented Federal Firearms License). Winners shall be solely responsible for any costs, fees or charges associated with the shipping or transfer of a prize.

ADDITIONAL RULES:** Entrants assume all liability for any injury, loss or damage caused or claimed to be caused by your participation in the Sweepstakes and/or the acceptance, awarding, receipt, use and/or legal or illegal misuse of any prize, and hereby fully and unconditionally release and agree to hold harmless and indemnify, including all their legal fees and costs, the Sponsors' respective affiliates, subsidiaries, directors, employees and agents, and all others associated with the development and execution of this sweepstakes from any such liability.
