

Official Rules for Michigan United Conservation Clubs

85th Anniversary Firearm Sweepstakes

1. NO PURCHASE, DONATION OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE, DONATION OR PAYMENT WILL NOT IMPROVE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

2. ELIGIBILITY: Sweepstakes is open to legal residents of the STATE OF MICHIGAN age 18 or older and otherwise eligible to purchase a firearm. All federal, state and local laws and regulations apply. Employees and their immediate families (parents, children, spouse, siblings) of the MICHIGAN UNITED CONSERVATION CLUBS (“MUCC”), its affiliates, subsidiaries, sales representatives and/or distributors, and all other companies involved with the development or execution of this Sweepstakes (collectively referred to “Released Parties”) and their immediate families, advertising and promotion agencies and those living in the same household of each (whether related or not) are NOT ELIGIBLE TO ENTER.

3. ENTRY PERIOD: The Michigan United Conservation Clubs (“MUCC”) 85th Anniversary Firearm Sweepstakes begins at 12:01 a.m. Eastern Time (ET) on JANUARY 1, 2023 and ends 8:30 p.m. (ET) on March 25, 2023 (“Entry Period”).

4. HOW TO ENTER: There are three ways to enter the sweepstakes. (I) Membership/Subscription Method: During the Entry Period join MUCC or extend or renew or upgrade your MUCC membership by (a) following all instructions to complete and return an official “Membership form” to MUCC via mail; (b) by calling 800-777-6720 to speak to a MUCC representative asking to enter into the 85th Anniversary Firearms Sweepstakes by joining MUCC; (c) or log onto www.mucc.org/about (“Website”) and follow the online instructions to join or extend or renew or upgrade your membership. Entrants participating in the Membership/Subscription Method will receive the following number of entries (up to a maximum of ten (10) entries per person) into the Grand Prize Drawing after their payment has been received for the corresponding action(s):

(II) Donation Method: During the entry period make a donation to MUCC by (a) logging onto www.mucc.org/donate (“Donation Page”) and donate a minimum of \$35 dollars for one entry into the Grand Prize Drawing. Entrants participating in the Donation Method will receive one (1) entry for each \$35 dollars donated (up to a maximum of ten(10) entries per person) into the Grand Prize Drawing. Donations must be made to the “85th Anniversary Firearms Sweepstake” campaign in the drop down on the donation page. Only donations to this campaign will be entered.

(III) Alternate Method: During the entry period mail complete a 3” x 5” postcard with your name, address, age, email address and daytime phone number legibly hand-printed in ink in capital letters, then sign your name in ink at the bottom of the card. Mail the card with sufficient pre-paid postage to MUCC, 2101 Wood Street, Lansing, Michigan 48912. Entries must be mailed separately (up to a maximum of ten (10) entries per mailing/return address). Entries must be postmarked by March 17, 2023 and must be received at MUCC’s headquarters 2101 Wood Street, Lansing MI 48912 no later than 11:59 p.m. (ET) on March 24, 2023 or in person at the 2023 MUCC Annual Convention no later than 8:30 PM (ET) on March 25, 2023 (MT. PLEASANT COMFORT INN & SUITES, 2424 S. Mission St., Mount Pleasant, MI 48858). All entries become the property of MUCC and will not be returned or acknowledged. Limit 10 entries per person.

5. CONSUMER DISCLOSURES: You have not yet won. No purchase necessary. For this Sweepstake, one prize will be awarded at the end of the Entry Period. Individual prize for Sweepstakes Approximate Retail Value (ARV): \$900.00. Maximum ARV of all prizes of Sweepstakes guaranteed to be awarded: \$900.00. Odds of winning depend on the number of eligible entries received during the Entry Period. Prizes are not transferable or redeemable for cash and no substitution of prize by a winner is permitted. All federal, state and local taxes, including but not limited to income taxes and firearm transfer fee, as well as any other incidental expenses not specified herein are the sole responsibility of each winner. Recipient/caregiver may request a way to be removed from the sponsor’s mailing list by sending, in writing, their name and address of the person to be removed to: Michigan United Conservation Clubs, 2101 Wood Street, Lansing, Michigan 48912. All federal, state, provincial and local taxes on a prize are the sole responsibility and liability of the prize winner. Sponsor will report the value of the prizes as required by law. An IRS Form 1099 will be issued to the winner

6. WINNER SELECTION: Winner for Sweepstakes will be selected from the eligible entries received during the Entry Period. All eligible entries will be combined as received during the entry period.

7. NOTIFICATION OF WINNERS: All random drawings will be conducted under supervision of MUCC whose decision is final and binding. Each winner will be notified by mail, phone or email within 14 days after the drawing or when firearm prizes are in MUCC's inventory. To be declared a winner, all potential winners must satisfy all applicable state and federal laws concerning firearm ownership and possession prior to receiving the firearm prize. If the potential winner is ineligible to receive the prize, an alternate winner will be selected. Prizes will be awarded within 30 days after prize notification. If a prize notification is returned as undeliverable, or the winner fails to respond to prize notification after 21 days, it will result in disqualification, and the corresponding prize will be awarded to an alternate winner in a separate random drawing from all non-winning eligible entries. Entry & acceptance of prize constitute permission to use a winner's name, prize won, hometown & likeness for promotional purposes including online posting with- out further compensation, except where prohibited by law. Winners shall be provided the option to receive their prize in person at a location determined by MUCC. Alternatively, winners may request that their prize is shipped to an eligible receiving location of their choosing (location must provide documented Federal Firearms License). Winners shall be solely responsible for any costs, fees or charges associated with the shipping or transfer of a prize.

8. PRIVACY POLICY: Any personally identifiable information collected during an entrant's participation in the sweepstakes will be collected by MUCC, and will be used by MUCC for purposes of the proper administration and fulfillment of the sweepstakes as described in these Official Rules and in accordance with MUCC's Privacy Policy as stated at www.mucc.org/sweepstakes and any communications an Entrant may agree during the registration process to receive in the future.

9. ADDITIONAL RULES: Entrants assume all liability for any injury, loss or damage caused or claimed to be caused by your participation in the Sweepstakes and/or the acceptance, awarding, receipt, use and/or legal or illegal misuse of any prize, and hereby fully and unconditionally release and agree to hold harmless and indemnify, including all their legal fees and costs, the Sponsors' respective affiliates, subsidiaries, directors, employees and agents, and all others associated with the development and execution of this sweepstakes from any such liability. Winners acknowledge that Sponsors and all other companies concerned with this Sweepstakes and their agents do not make, nor are in any manner responsible for, any warranty, representations, expressed or implied, in fact or in law, relative to the quality, conditions or fitness of any aspect of the prizes. However, each prize will be subject to the manufacturer's standard warranty. Prizes for this Sweepstakes are subject to availability at the time of drawing. A comparable prize or model will be awarded if the current model is not available at the time of drawing.
