Proposed Resolution #A Requires 2/3 Majority

Submitted by: Craig Larson, Dowagiac Conservation Club MUCC Region: 7

Proposed: August 17, 2024 CPB Meeting

Title: Deer Hunting Equipment - Limited Firearm Zone

- 1. **WHEREAS:** under current Michigan regulations (pages 49 50 of the 2023 Michigan
- 2. Hunting Digest), a legal firearm for deer hunting in the Limited Firearm Zone is defined
- 3. as .35 caliber or larger rifle loaded with straight walled cartridges with a minimum case
- 4. length of 1.16 inches and a maximum case length of 1.8 inches, and;
- 5. WHEREAS: many hunters, have straight wall cartridges of greater than 1.8 inches,
- 6. particularly of historic nature, the change to all straight-walled cartridge calibers from a
- 7. maximum of 1.8" case length to a maximum of 2.2" maximum case length would benefit
- 8. many hunters, and;
- 9. WHEREAS: the minor change from 1.8" to 2.2" eliminates any concerns for the longer
- 10. length straight wall cartridges and still allows the most common straight wall cartridges
- 11. that have been requested on a routine basis, and;
- 12. WHEREAS: The minor change in length also minimizes concerns over the potential for
- 13. new cartridge development, and;
- 14. WHEREAS: The 2.2" maximum case length also provides the CO's similar enforcement
- 15. of maximum case length they are accustomed to currently, and;
- 16. WHEREAS: this proposed rule change to allow the maximum case length to be
- 17. extended to 2.2" will allow for the use of many of traditional deer hunting cartridges
- 18. commonly owned in Michigan for the Limited Firearms Deer Zone and will be beneficial
- 19. to the State of Michigan without increased risks to the public or the hunting community, 20. NOW:
- 21. THEREFORE, BE IT RESOLVED: that MUCC work with the Natural Resources
- 22. Commission or the Michigan Legislature as necessary to change the regulation to allow
- 23. deer hunters to use straight wall cartridges .35 caliber or larger with maximum case
- 24. length of 2.2" in the Limited Firearms Zone.

Title: Opposition to Market Hunting of Game Animals

- 1. WHEREAS: the Michigan United Conservation Clubs (MUCC) has supported the North
- 2. American Model of Wildlife Conservation (NAMWC) 's pillars since its inception, and;
- 3. **WHEREAS:** As articulated by the U.S. Fish and Wildlife Service, seven features make the
- 4. North American model distinct, and;
- 5. **WHEREAS:** Wildlife is a public resource and held in public trust. In the United States,
- 6. wildlife is considered a public resource, independent of the land or water where wildlife
- 7. may live. Government at various levels have a role in managing that resource on behalf
- 8. of all citizens and to ensure the long-term sustainability of wildlife populations, and;
- 9. WHEREAS: Markets for game have been eliminated. Government actions making it
- 10. illegal to buy and sell meat and parts of game and non-game species have removed a
- 11. huge threat to the survival of those species. A market in furbearers continues as a highly
- 12. regulated activity, and;
- 13. WHEREAS: Allocation of wildlife by law. Wildlife is a public resource managed by the
- 14. government. As a result, access to wildlife for hunting is through legal mechanisms such
- 15. as hunting seasons, bag limits, license requirements, etc, and;
- 16. WHEREAS: Wildlife can only be killed for a legitimate purpose. Wildlife is a shared
- 17. resource that must not be wasted. The law prohibits killing wildlife for frivolous reasons,
- 18. and;

- 19. WHEREAS: Wildlife species are considered an international resource. Some species,
- 20. such as migratory birds, cross national boundaries. Treaties such as the Migratory Bird
- 21. Treaty and Convention on International Trade in Endangered Species (CITES) recognize a
- 22. shared responsibility to manage these species across national boundaries, and;
- 23. WHEREAS: Science is the proper tool for discharge of wildlife policy. To manage wildlife
- 24. as a shared resource fairly, objectively, and knowledgeably, decisions must be based on
- 25. sound science such as annual waterfowl population surveys and the work of professional
- 26. wildlife biologists, and;
- 27. WHEREAS: The democracy of hunting and fishing. In keeping with democratic
- 28. principles, government allocates access to wildlife without regard for wealth, prestige, or
- 29. land ownership, and;
- 30. WHEREAS: The North American Model of Wildlife Conservation is credited with
- 31. restoring many of North America's wildlife species that had been at or near the brink of
- 32. extinction due to market hunting, including whitetail deer, black bears, elk, Canada
- 33. Geese, wild Turkeys and many more, NOW;
- 34. **THEREFORE**, **BE IT RESOLVED**: MUCC supports the seven pillars of the North
- 35. American Model of Wildlife Conservation, and;
- 36. BE IT FURTHER RESOLVED: MUCC opposes any market hunting for management
- 37. purposes.

<u>Proposed Resolution #C</u> <u>Requires Simple Majority</u>

Title: Support Conservation Over Preservation Whenever Possible

- 1. WHEREAS: Michigan United Conservation Clubs is the largest statewide
- 2. conservation organization in the nation. Founded in 1937, our mission is to unite citizens to
- 3. conserve, protect and enhance Michigan's natural resources and outdoor heritage. This
- 4. mission drives everything we do as an organization; and,
- 5. WHEREAS: some nonprofit organizations will twist the words conservation and preservation to
- 6. fit their narrative. It's important we do not fall for these twisted semantics. Conservation can
- 7. quickly become an anti-hunting term when used improperly; and,
- 8. WHEREAS: Aldo Leopold once said "To keep every cog and wheel is the first precaution of
- 9. intelligent tinkering." Humans are cogs in the natural machine. Preservation often implies or
- 10. directly eliminates the human element in nature and the wise use of natural resources, NOW;
- 11. THEREFORE BE IT RESOLVED: MUCC recognizes conservation as the wise use of natural
- 12. resources today, while ensuring the resource can be wisely used into the future, and,
- 13. BE IT FURTHER RESOLVED: MUCC recognizes preservation as seeking to prevent nature
- 14. from use; and
- 15. BE IT FURTHER RESOLVED: MUCC recognizes the importance of the human element within
- 16. nature and everything that comes with it. MUCC will support conservation over preservation
- 17. whenever possible.

Proposed Resolution #D Requires ²/₃ Majority

Title: Expand Underwater Spearfishing Opportunities

1. **WHEREAS**: Michigan United Conservation Clubs (MUCC) is the largest statewide conservation

- 2. organization in the nation. Founded in 1937, our mission is to unite citizens to conserve, protect
- 3. and enhance Michigan's natural resources and outdoor heritage. This mission drives everything
- 4. we do as an organization, and;
- 5. WHEREAS: MUCC has already adopted Policy Resolution AC100601 which supports
- 6. clear definitions of waters open to spear and bow fishing along with additional opportunities
- 7. and improved access to them, and;
- 8. WHEREAS: Underwater Spearfishing is an ecological, selective and sustainable method of
- 9. harvest, and;
- 10. WHEREAS: Michigan enjoys the largest bodies of freshwater (Great Lakes) in America
- 11. with ample space for Underwater Spearfishing to take place without conflicting with other
- 12. angling methods. The Michigan Department of Natural Resources (MDNR) confirmed there
- 13. were zero reported conflicts between spear anglers and rod and reel anglers on an April 3,
- 14. 2024, fisheries meeting, and;
- 15. WHEREAS: Multiple non-coastal inland states such as Wisconsin, North Dakota, South
- 16. Dakota, Utah, Arkansas, Wyoming, New Mexico and others with comparatively fractional water
- 17. acreage to land mass have equal opportunity for underwater spearfishing anglers and hook
- 18. and line anglers regarding table-worthy game fish availability, and;
- 19. WHEREAS: The seasons, size and possession limits for all species are to be adhered to by all
- 20. anglers and angling methods to mean that the harvest of fish utilizing underwater spearfishing
- 21. equipment shall not harm the resource, and;
- 22. WHEREAS: MDNR fishery biologist have stated emphatically there is no biological impact to
- 23. the fishery, and;
- 24. WHEREAS: current regulations require underwater spear anglers to be fully submerged when
- 25. attempting to harvest fish, the seasonal conditions limit access to the water based on
- 26. temperature and visibility, artificial breathing devices such as scuba and rebreathers are
- 27. Prohibited, and;
- 28. WHEREAS: MUCC supports expanding seasons and/or methods of take when sound science

- 29. supports such an opportunity, and;
- 30. WHEREAS: Any opposition to expansion of this method of take (underwater spearfishing) is
- 31. purely based on unsubstantiated perceived social pressure which will not stand within this
- 32. organization, and;
- 33. WHEREAS: Any opposition to this resolution would make you complicit and supportive of the 34.
- 34. NRC limiting the coyote season without any sound scientific support and relying on only35.33.
- 35. unsubstantiated perceived social and political pressure, and;
- 36. WHEREAS: Again, there is no biological impact on the fishery, and there have been zero
- 37. reported conflict between various angling methods, NOW;
- 38. THEREFORE, BE IT RESOLVED: Because As long as it is supported by sound science
- 39. provided by our MDNR fishery biologists that MUCC adopt the policy to create fair access to
- 40. Michigan's aquatic resources and support the expansion of underwater spearfishing
- 41. opportunities for table worthy gamefish species to coincide with current species-specific
- 42. regulations and include waters and species enjoyed by hook and line anglers throughout the
- 43. state so long as there is no scientifically proven negative impact on the fishery. in the Great
- 44. Lakes and Great Lakes connecting waters, as defined by Lake St. Clair, St. Clair River, St.
- **45.** Mary's River, Detroit River, and to exclude designated trout lakes, designated trout streams, and
- 46. tribal treaty waters.

Proposed Resolution #E Requires 2/3 Majority

Proposed: August 17, 2024 CPB Meeting

Title: Bear treestands at legal bait sites prior to Sept 1

- 1. **WHEREAS:** Currently, it is unlawful to place tree stands on public land prior to September
- 2. 1st, and;
- 3. WHEREAS: Baiting for bear is lawful beginning 31 days prior to the start of bear season,
- 4. and;
- 5. WHEREAS: Being obligated to wait until September 1st, or over two weeks after baiting
- 6. has begun to place one's tree stand on public land would cause undo intrusion, and
- 7. potentially pattern changing activity into one's bait site, NOW;
- 8. **THEREFORE, BE IT RESOLVED:** MUCC work with the proper parties to give bear hunters
- 9. the ability to place their tree stand on public land at actively tended legal bait sites, and
- 10. ONLY at actively tended legal bait sites, beginning the day baiting becomes legal.

DISCARDED AS INCONSISTENT WITH THE MISSION

Proposed Resolution #F Requires ²/₃ Majority

Title: Support for eliminating the whitetail bait ban that was established in 2019

for the entire Lower Peninsula of Michigan

1. WHEREAS: Deer harvest numbers are down in all but 6 counties in 2023 compared to 2022,

- 2. with an overall decline in harvest of over 9% for the State, and;
- 3. WHEREAS: There were 58,984 deer-involved crashes in Michigan in 2022, Michigan State
- 4. Police data compiled by the Insurance Alliance of Michigan (IAM) shows. That's an increase of
- 5. 13% from 2021, and;
- 6. WHEREAS: The deer herd rapidly growing at this rate will be the leading cause of disease
- 7. spread in Michigan whitetail deer moving forward. Hunters harvested roughly 30,000 less deer
- 8. in 2023 than they did in 2022, and;
- 9. WHEREAS: The DNR charts the prevalence rate of bovine tuberculosis (bTB) among all deer
- 10. that tested positive for bTB in Deer Management Unit (DMU) 452 from 1995 through 2023.
- 11. Baiting deer for hunting has been illegal in DMU 452 since 2002. There has been little change
- 12. In the prevalence rate of the disease since then. The bait ban has not impacted or mitigated the
- 13. spread. The prevalence rate usually varies from one year to the next, but not enough to
- 14. Confirm a ban on baiting has reduced the spread of the disease. The prevalence rate of bTB
- 15. among wild deer in DMU 452 during 2003 and 2004, for example, is listed as 1.7%. The
- 16. Prevalence rates of the disease for 2022 and 2023 are exactly the same at 1.7%, and;
- 17. WHEREAS: Deer physically interact with each other. Doe with their young, mating, licking
- 18. branches, fighting, scrapes, and even feeding naturally on apples, cherries, sugar beets, corn,
- 19. soybeans, and acorns. Bait spread out over a reasonable area is not a significant change to the
- 20. natural behavior of deer, and:
- 21. WHEREAS: Hunters' success rates have declined due to the bait ban 2020-2022 there was an
- 22. increase in hunters due to the pandemic, but now that hunter numbers are back to pre-2020
- 23. levels, the success rates are significantly lower than in 2019. Even though there are more deer
- 24. now, and;
- 25. WHEREAS: Many Michigan hunters get 1-2 weeks of vacation time per year from work. This

- 26. leads to most deer hunters only spending 3-5 days in the field. With the bait ban impacting the
- 27. harvest rates negatively, many have lost interest in hunting. We need to harvest more deer for
- 28. the health of the herd, and to keep hunters interested and buying licenses for conservation
- 29. funding, and;
- 30. WHEREAS: The use of bait helps position deer for a hunter to make a clean and ethical kill
- 31. shot. Especially new and disabled hunters, and;
- 32. WHEREAS: Bait is sold all over the state of Michigan and many hunters still secretly bait. This
- 33. creates an unstable and negative relationship between the DNR and hunters because hunters
- 34. know they are breaking the law. They will not call, communicate or help the DNR because they
- 35. do not want their secret baiting to be discovered. They certainly won't report to the DNR or
- 36. Have them out on their property. Positive and helpful communication between the DNR and
- 37. licensed hunters is critical for conservation success, and:
- 38. WHEREAS: Laws or regulations that impact hunters and do not make scientific sense, cause
- 39. distrust of the DNR and leads to disinterest in the sport itself, and;
- 40. WHEREAS: A large portion of MUCC membership is made up of hunters in the southern
- 41. Zones. Many of these hunters have access to hunt agriculture fields and do not see the need
- 42. For baiting. Those hunters should be mindful of their Northern Michigan brothers and sisters
- 43. who are greatly impacted by the bait ban when they vote. We are all in this together, NOW;
- 44. THEREFORE, BE IT RESOLVED: MUCC will work with the Michigan DNR to eliminate the
- 45. current bait ban and implement a new deer baiting program that legalizes baiting. The new
- 46. program would allow hunters to bait two days prior to and during all deer hunting seasons. The
- 47. bait must be limited to 5 gallons and spread out evenly over a minimum of a 5-yard square.
